## 178. DRAFT BUDGET 2011/12

The Town Clerk and Finance Officer submitted for Members' consideration, their joint report (copy of Draft Budget and accompanying statements circulated with Agenda), providing budget monitoring information for the current financial year and seeking to determine the Council's Budget, Management and Operational Plan and precept for the financial year 2011/2012 and indicating:

- (i) that the Council was required to approve a balanced revenue budget;
- (ii) that the figures presented would necessitate levying a precept of £401,000 (equivalent to a 2.5% average increase per week in Council Tax per

household for Town Council services) or otherwise the Committee could determine a lower figure provided that they also identified corresponding savings from the revenue budget;

(iii) that additionally, other limited reserves within the Community Development Fund were available to support the Council's prioritised projects, details of which were set out within Appendix A and B of the report;

Following introductory remarks and points of explanation the Finance Officer responded to several detailed questions put by Members. Discussion followed on how the Council's expenditure might be reduced in 2011/12 in order to meet estimated and significant election costs in 2012. Two separate proposals were considered but were lost when put to the vote. Following further discussion it was:

## RESOLVED that:

- a) the probable figures for 2010/11 and the Budget figures for 2011/12 be approved as set out in Appendix D.
- b) the existing expenditure commitments and indicative allocations for the Community Development Programme be noted as set out in Appendix A and B but subject to the sum of £7,000 being set aside from the identified balance for the specific purpose of meeting election costs in 2012.
- *c) the appointment of the Internal Auditor for work related to the financial year 2011/12 be approved.*
- d) the Balances Policy Statement be approved as stated "Following approval of the Budget and Precept for the financial year 2011/12 the projected level of revenue balances as at 31st March 2012 will be circa £140,000 and considered in aggregate with the Council's other expenditure commitments and proposals from its Community Development Fund are deemed appropriate for an authority of this size".
- e) the Town Council's Investment Strategy as set out in Appendix F of the report be approved.
- f) authority for the Town Clerk to act with regard to the Budget and Community Development Programme to spend such sums as approved without further reference back, be confirmed.
- *g)* the Council levies a precept of £401,000 (Four Hundred and One Thousand Pounds) upon Denbighshire County Council for the financial year commencing on 1<sup>st</sup> April 2011, Denbighshire County Council to be advised accordingly.

At the conclusion of the item Members and the Town Clerk congratulated and thanked the Finance Officer on the excellent draft budget document which had stimulated very thorough and healthy debate in the Chamber.

# 179. <u>CONFERENCE: SOCIETY OF LOCAL COUNCIL CLERKS CLWYD AND</u> <u>GWYNEDD JOINT BRANCH CONFERENCE</u>
