38. NORTH WALES TOURISM: RHYL TOURISM INFORMATION CENTRE (TIC)

To receive and determine the Town Clerk's confidential report (copy enclosed) following the proposed closure of the centre during the winter season due to a drop in income generated by the TIC since a number of companies have taken their ticket sales in-house, despite footfall remaining high.

Members were in agreement that the TIC was important for Rhyl, which was evidenced by the 11,000 visit footfall from October to March 2022/23, and would like to see the centre open this winter.

RESOLVED that the Town Clerk to offer the TIC half of their income loss (£7,500) in the hope that they can secure funding for the remaining £7,500 from other funding sources.

<u>FURTHER RESOLVED</u> that Standing Orders be suspended to enable the Town Clerk to respond as a matter of urgency.

40. ADDITIONAL ITEM: RHYL COMMUNITY BONFIRE & FIREWORKS

The Town Clerk reported that the Fire Station Welfare and Recreation Club had recently confirmed that the event will go ahead this year, and asked members to

consider contributing the usual level of funding to the value of £5,000 for the purchase of the fireworks.

The Town Clerk added that he had enquired about the use of silent fireworks, as members had requested last year, but that they would not be used as they were not the Fire Station Welfare and Recreation Club's preference, as they were felt to diminish the atmosphere of the event and were not popular with the attending public.

RESOLVED that the Town Clerk was authorised to make the payment of £5,000.
